## The Club Foundation CMAA 2023 World Conference Raffle Official Rules

**VOID WHERE PROHIBITED BY LAW.** Subject to all applicable federal, state, and local laws, regulations, and ordinances. Raffle begins on Friday, February 24, 2023 at 12:01 a.m. Eastern Time ("ET"). The Raffle will close at 5:00 p.m ET on Monday, February 27, 2023.

- 1. Eligibility: The Club Foundation CMAA 2023 World Conference Raffle (the "Raffle") is open to legal U.S. residents currently residing in the 50 United States and the District of Columbia who are 18 years old or the age of majority, whichever is older as of the date of entry, and who attend the 2023 CMAA World Conference at the Gaylord Palms Resort in Orlando, Florida. Employees, officers, and directors of The Club Foundation ("Sponsor") or any of its parents, affiliates (including The Club Management Association of America), subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment, and marketing agencies, and members of their immediate families (spouses, parents, siblings and children, regardless of where they live) and those living in the same household are not eligible to enter or win. Participation constitutes entrant's full and unconditional agreement to these Official Rules and to Sponsor's decisions, which are final and binding in all matters related to the Raffle. Winning a prize is contingent upon fulfilling all requirements set forth herein. Sponsor reserves the right to verify the eligibility of winners.

- 3. How to Enter and Suggested Donations: During the Raffle Period, go to https://2023wscf.givesmart.com and complete and submit the registration form, including a valid home address, name and email address. Upon completion and submission of the registration form, you automatically will be entered with one (1) entry into the Raffle. In your registration form, you may specify the amount you wish to donate to the Sponsor. Whether or how much you donate will not affect your chances of winning; no purchase or donation is necessary to enter. You must provide all required information to be eligible to enter and win. All potential winners are subject to verification before any prize will be awarded. By registering, you agree that Sponsor may contact you via email. Limit: LIMIT ONE (1) ENTRY PER PERSON. ADDITIONAL ENTRIES WILL BE DISQUALIFIED. Entries must be submitted by the contestant. No copies, facsimiles, or mechanical reproductions of the Entry Form will be accepted. Any attempt by any participant to obtain more than the stated number entries by using multiple and/or different identities, forms, registrations, email addresses, logins, or any other methods will void that participant's entries, and that participant may be disqualified at Sponsor's discretion. Multiple participants are not permitted to share the same email address. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder to the Sponsor or forfeit the prize. Entries specifying an invalid, non-working, or inactive email address will be disqualified and ineligible to win. You must complete all required information to be eligible to enter. Incomplete, illegible, corrupted, or untimely entries are void and will be disqualified.

**4. Selection/Notification of Winner:** On Tuesday, February 28, 2023, at between 1:45 p.m. and 3:30 p.m. ET during the CMAA Closing Business Session ("**Drawing Date**"), Sponsor will select the name of the potential winner of the prize in a random drawing from all raffle tickets purchased. The odds of winning are based on the number of eligible entries received. The potential Winner will be notified by email on or about Tuesday, February 28, 2023. Except where legally prohibited, the potential Grand Prize winner must sign and return, within seven (7) days of being notified, a Declaration of Eligibility, Liability & Publicity Release (the "**Declaration**") to claim the potential Winner's prize. If a potential Winner cannot be contacted in person via email, telephone, and/or registered mail after the first attempt to contact him/her, or if he/she fails to sign and return the Declaration within the required time period (if applicable), or in the event that a potential Winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner selected by a random drawing from among all remaining eligible entries. Only one (1) alternate drawing will be held, after which any remaining prizes will remain un-awarded

Verification of Potential Winner: ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE RAFFLE. **5. Prize**. One Grand Prize will be awarded. The Grand Prize consists of a cash prize of fifty percent (50%) of the total monetary donations submitted to Sponsor in connection with each raffle ticket purchase for the Raffle. Approximate Retail Value ("ARV") and total ARV of the Grand Prize: will be fifty percent (50%) of the total cash donations received by Sponsor in connection with the Raffle. Limit one prize per person and per household. The Grand Prize will be awarded to the Winner in cash or by check, or as otherwise may be determined by the Sponsor in its sole discretion.

PRIZE RESTRICTIONS: Limit one (1) prize per person, per household. Any and all applicable federal, state, and local taxes and all fees and expenses related to acceptance and use of prize not specifically stated herein, including but not limited to, change of air travel fees, ground transportation, automobile insurance, meals, incidentals, passenger tariffs or duties, surcharges, service charges or facility charges, personal charges at lodging, security fees and/or other expenses, are the responsibility solely of winner. Prize cannot be substituted, assigned, or transferred; however, Sponsor reserves the right to make equivalent prize substitutions at its sole discretion. Sponsor will not replace any lost or stolen prize. Only the number of prizes stated in these Official Rules is available to be won in the Raffle. If, by reason of a print or other error, more prizes are claimed than the number set forth in these Official Rules, an alternate winner will be selected in accordance with the winner selection method described above from among all eligible claimants making purportedly valid claims to award the advertised number of prizes available.

**6. General Conditions.** If, for any reason, the Raffle is not capable of running as planned, including infection by computer virus or bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsor which corrupt or affect the operation, administration, security, fairness, integrity, or proper conduct of this Raffle, Sponsor may, in its sole discretion, void any suspect entries and (a) cancel or terminate the Raffle (or any portion thereof); (b) modify the Raffle or suspend the Raffle to address the impairment and then resume the Raffle in a manner that best conforms to the spirit of these Official Rules; and/or (c)

award the prize from among the eligible, non-suspect entries received up to the time of impairment, and all eligible entries received.

Sponsor reserves the right at its sole discretion to disqualify any individual it finds to be attempting to tamper with or undermine the entry process, and/or the legitimate operation of the Raffle; to violate the Official Rules; or to act in a disruptive manner or with the intent to annoy, abuse, threaten, or harass any other person. Entrants agree that Sponsor shall own the entries, which shall not be acknowledged or returned.

PURSUANT TO ITS AUTHORITY, THE RIGHT AND PERMISSION TO PRINT, PUBLISH, BROADCAST, AND USE, WORLDWIDE IN ANY MEDIA NOW KNOWN OR HEREAFTER DEVELOPED, INCLUDING BUT NOT LIMITED TO THE WORLD WIDE WEB, AT ANY TIME OR TIMES, THE WINNER'S NAME, PORTRAIT, PICTURE, VOICE, LIKENESS, OPINIONS AND BIOGRAPHICAL INFORMATION (INCLUDING WITHOUT LIMITATION HOMETOWN AND STATE) FOR ADVERTISING AND PROMOTIONAL PURPOSES WITHOUT ADDITIONAL CONSIDERATION, COMPENSATION, PERMISSION, OR NOTIFICATION.

- **9. Disputes.** Except where prohibited by law, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Raffle or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the District of Columbia or the appropriate State Court located in Washington, D.C.; (2) any and all claims, judgment, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Raffle, but in no event attorneys' fees; (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, any and all rights to have damages multiplied or otherwise increased.
